## How We Prepare Documentary Credits ?

We usually request you to open a letter of credit in favor of us, after receipt of your master L/C. We open back to back L/C for fabric & accessories needed for your order. It is therefore very important that your L/C reaches us on time as the production process depends on it. For your reference, a customized L/C specimen is sent along with there-forma invoice for each order.

By central bank on the B/L your documentary credit must be irrevocable, transferable and payment at sight (adding confirmation is sometimes requested). It must be made available with any bank. Please pay attention to a special mention requested full clean on board ocean bill of lading made out to the order of negotiating bank in Bangladesh, endorsed to the order of your bank, notify yourself. Also, as all goods transit through Singapore, transshipment must always be allowed. Period for presentation of documents: 15 days.

### Quality Control Section

Our factory maintains a strong Quality Control (QC) system with qualified quality controller across 10 lines to ensure top-quality production. The QC team monitors every stage – from fabric inspection, cutting, sewing, and finishing to final audit – following international AQL standards. Special attention is given to fabric quality, workmanship, measurement accuracy, and finishing standards to meet buyer requirements and achieve consistent, defect-free garments. QC checks each aspect of operation and AQL as per buyer recommended and used to the **Managing Director/ CEO**. He has right to stop production if a quality standard is not up to the mark.

### Finishing Section & Steam Iron

Finishing section is well equipped. Garments are again measured against the specification. If garments are within tolerance level they are pressed on packed, cartoned and waits for final inspection. 10 Steam Irons are in Finishing Section.

# Worker's Benefits

- The Management has ensured all types of workers benefit as well as addressed all compliance related issues as per local regulatory laws and customer's advice.
- Management ensured minimum wages and benefits for workers and employees.
- All workers/employees are given pay-slips showing detailed breakdown of their entitlements.

5. **Electrician:** All concealed wiring are most modern systems with proper safety measure.
6. **Ventilation:** Full facilities for proper ventilation and light.
7. **Dress:** Apron, cap and mask provide to every single worker for occupational health and safety measure.
8. **Baby care:** Worker's new born babies are taken care by trained nurse while mother is at work.
9. **Healthy facilities:** Arrangement of monthly checkup by a qualified and experienced physician and first aid facilities are also available.
10. **Prayer room:** Space provided to workers for prayer.
